GETTING STARTED

1. Owners must be competing members of the CIEF in Good Standing.
2. We require evidence of ownership via either a copy of the horse's Breed registration documents or a bill of sale signed by both parties (price can be blacked out)
3. If the horse has a breed registration or a national passport from another country, a copy of such papers, including cover page, must be submitted with the application. If your horse already has a national passport or an FEI Passport issued by another national federation, you will be issued an FEI Recognition Card rather than an FEI Passport.
4. The fee for an FEI Passport or FEI Recognition Card for a horse that is already registered in the FEI database is CI\$300.00. This fee consists of the CIEF Passport or Recognition Card processing fee of CI\$100, plus the FEI Passport or Recognition Card fee of Swiss Franc 175 (approximately CI\$150.00), plus the wire transfer fee to send funds to the FEI of CI\$50.00
5. If the passport must be shipped overseas to you, a \$100 fee will apply (via DHL)
6. If the horse is not already registered with the FEI there will be an additional CI\$25.00 Horse registration fee.
7. These fees are subject to change with currency fluctuations and are the sole responsibility of the owner.
8. Expedited service is not available at this time.

FEES FOR HORSE NAME CHANGE

A horse must be registered with the FEI with its Birth Name (see below). The adoption of a new name that is different than the Horse Birth Name or any modification/change to the name of the horse in the FEI database after issuance of a Passport or Recognition card is subject charges by the FEI that can run up to KYD 1,000. Please contact the CIEF for the exact charges.

What is a Horse Birth Name?

1. The name of the horse in the initial registration document issued at or shortly after birth
2. If (1.) is not applicable, the name of the horse in the first birth studbook document.
3. If the horse is not affiliated with any studbook, the birth name of the horse is the name written in the first document issued (either national passport/first original document, or FEI recognized document, or FEI Passport)
4. If 1, 2, and 3 are not applicable the name on the name on the Bill of Sale is the birth name of the horse.
5. If 1, 2, 3 and 4 are not applicable, the name that the horse is known by, is considered the birth name of the horse.
