



Policy for Use of the Pixio Camera System

(November 22nd, 2020 Revision)

1. The Pixio Camera System, with or without the related CeeCoach communication system (the "Pixio"), may only be used by Members of the CIEF that are in Good Standing.
2. The Pixio may only be operated by adults, meaning those aged 18 or older, but may be used to film any Member of any age.
3. The Pixio may be used in lessons, clinics, competitions or any other time, but only for training/educational purposes. It is not to be used for commercial, entertainment or other non-training/educational purposes without the express written permission of the Board of the CIEF.
4. The Pixio may be used to take remote lessons or clinics with coaches located overseas, but if such lesson or clinic is **not** organized by the riding stable or the CIEF, then the individual(s) taking the remote lesson or clinic must first obtain permission from the owner of the riding stable where filming is taking place. The owner of such riding stable may, at their discretion, charge a fee for the use of their facility for remote instruction via the Pixio.
5. The show committee shall be in charge of the Pixio and responsible for
 - training users,
 - managing distribution and collection of Pixio Reservation Forms,
 - taking inventory of the Pixio's components and assessing any damage upon return, and
 - communicating charges owed by Members for use of the Pixio to the Treasurer
6. Charges for use of the Pixio shall be as follows:
 - For use in a lesson taken locally - \$10 per lesson recorded
 - For use in recording one's riding without an instructor - \$10 per ride per horse/rider combination recorded, except for those designated as "Elite" athletes by the CIEF for which there will be no charge.
 - For use with a lesson with an overseas coach - \$10 per lesson live-streamed for all Members, except those designated as "Elite" athletes by the CIEF for which there will be no charge.
 - For clinics run with an overseas clinician by an Affiliated riding school or by the CIEF, \$10 per clinic recorded or \$10 per clinic live-streamed as the case may be.
 - For recording a performance at a CIEF horse show - \$10 per horse/rider combination recorded
 - For shows run by the CIEF where the Pixio is used in place of the judge, there will be no charge unless a horse-rider combination asks that the performance be recorded, for which the preceding bullet point applies.
7. Fees for use of the Pixio must be paid in advance of its use.
8. Damage to the Pixio: Members are expected to use reasonable care whilst the Pixio is in such Member's possession. In the event of any damage or loss to any component of the Pixio due to the negligence of the Member or otherwise, the CIEF reserves the right to seek payment from the Member up to a maximum amount of CI\$100 which will be used as a contribution to the repair of such damaged or lost component.
